Notes from the Rostrum

With 18 lots on offer and still available at the time of going to print, we are pleased to be hosting our third auction of 2025, and we wish you a warm welcome to our sale held on the 21st of May 2025. Our auction on the 2nd of April was successful, we had a full room of registered buyers achieving an average of 18% over our advertised guide prices and a gross property sale figure of £1,467,000. The auction market feels vibrant with a vast array of people buying properties for very different reasons. So, whether you are looking for an investment property, a first home, a family home or a development opportunity, we will be delighted to see you in the auction room with your bidding cards held high.

So, what do we have to offer you in May. At the lower end of the scale, we have a single garage located in Fareham, right by the train station guided at $\pounds 20,000$. We have a mixture of traditional houses, a bungalow, flats, a retirement apartment, investment properties and a character lodge with guide prices up to $\pounds 335,000$.

If apartments are what you are looking for, we have 6 available in this auction, ranging in guide prices from £50,000 to £225,000. An example of these is a three-bedroom maisonette in Waterlooville guided at £165,000, a two-bedroom ground floor apartment in Petersfield guided at £225,000 and a studio apartment located in Southampton guided at £50,000. Homerise House in Winchester is a first-floor one-bedroom retirement apartment guided at £45,000.

Traditionally, bungalows always prove to be extremely popular, and, on this occasion, we have just the one available. 24a Granada Road, is a detached two-bedroom bungalow located down a private drive in Hedge End, Southampton guided at £335,000.

We have several properties in need of modernisation, along with properties that are ready to move into ranging from £150,000 to £300,000. Some examples of these are a three-bedroom fire damaged semi-detached house in

Southampton guided at £150,000, a three-bedroom midterraced non-standard construction house in Southampton guided at £185,000, a three-bedroom midterrace cottage in Horndean with two parking spaces guided at £225,000. Lastly, we have a four-bedroom, two reception room detached house in Fair Oak guided at £300,000, having countryside views and a good size gated plot.

Undermount Lodge in Bonchurch on the Isle of Wight is a truly charming Grade II listed lodge brimming with history and character. Believed to have been originally built in 1857 as a gate house to the manor next door, this unique two-bedroom property boasts stone detailing, along with an array of period features that make it a rare find and is guided at £250,000.

As you can see, we have a nice mix of properties, and we hope that there is something here to catch your eye. I sincerely believe this is one of the best buying opportunities we have seen for a long time, given the recent reductions in interest rates. - G23.3 Following completion the buyer must complete rent review negotiations or proceedings as soon as reasonably practicable but may not agree the level of the revised rent without the written consent of the seller, such consent not to be unreasonably withheld or delayed.
- G23.4 The seller must promptly:
 - a) give to the buyer full details of all rent review negotiations and proceedings, including copies of all correspondence and other
 - papers; and
 b) use all reasonable endeavours to substitute the buyer for the seller in any rent review proceedings.
- The seller and the buyer are to keep each other informed of the progress of the rent review and have regard to any proposals the other makes in relation to it.
- G23.6 When the rent review has been agreed or determined the buyer must account to the seller for any increased rent and interest recovered from the tenant that relates to the seller's period of ownership within five business days of receipt of cleared funds.
- If a rent review is agreed or determined before increased rent and any interest recoverable from the tenant has not been received by completion the increased rent and any interest recoverable is to be treated as arrears.
- G23.8 The seller and the buyer are to bear their own costs in relation to rent review negotiations and proceedings.

- G24. Tenancy renewals

 - a) with the co-operation of the seller take immediate steps to substitute itself as a party to the proceedings; b) use all reasonable endeavours to conclude any proceedings or negotiations for the renewal of the tenancy and the determination of any interim rent as soon as reasonably practiciable at the best rent or rents reasonably obtainable; and c) if any increased rent is recovered from the tenant (whether as interim rent or under the renewed tenancy) account to the seller for part of that increase that relates to the seller's period of ownership of the lot within five business days of receipt of cleared funds.
- G24.5 The seller and the buyer are to bear their own costs in relation to the renewal of the tenancy and any proceedings relating to this.

- G25.3 If a warranty is not assignable the seller must after completion:

 - a) hold the warranty on trust for the buyer; and
 b) at the buyer's cost comply with such of the lawful instructions of the buyer in relation to the warranty as do not place the seller in breach of its terms or expose the seller to any liability or month.
